California Education Code §68075.5 entitles a student who was a member of the Armed Forces of the United States stationed in this state on active duty for more than one year prior to being discharged shall be exempt from paying nonresident tuition for the length of time he or she lives in this state after being discharged up to the minimum time necessary to become a resident. The one year exemption shall be used while the student lives in this state and within two years of being discharged.
